

# Antimicrobial Flat Belts

## E-FB-F+H15

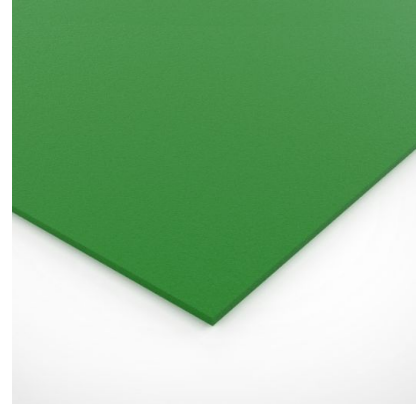


### Main applications

Flat belts are monolithic belts to convey goods in different applications or used as sideskirts. As an alternative they can be used as accessories for fabricated belts (i.e. as special cleats or sidewalls) or cover for timing belts.

### Description

Habasit flat belts are produced with smooth or embossed surfaces in TPU, hydrolysis resistant TPU and PVC in different thicknesses from 1.35 mm to 7 mm. Right products have to be selected on the base of the specific application.
