

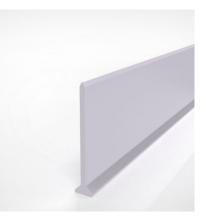
Main applications

Description

Narrow-based T-profile used as a cleat on Habasit TPU conveyor and processing belts.

Profiles are applied to the belt surface using a hot air or high frequency welding procedure.
